This is the statement of purpose for Spring Hall Group Practice which details the full name and address of the provider and all branch sites, the legal status of the provider, the aims and objectives of the provider and the range of services provided to its patients.

Spring Hall Group Practice is a General Practice limited company with 5 sites throughout Halifax Central Locality, open to all patients in the surrounding areas. We work together with our patients and our Patient Participation Group to provide medical care for our patients.

Spring hall Group Practice is a General Medical Services (GMS) Practice offering Primary Care services for the diagnosis and prevention of disease and to support general lifestyle choices. Doing this we support patients to manage their own health and prevent illness. Our clinical team assess, diagnose, treat and manage illness. They carry out screening for diseases and promote general health and wellbeing. The team works to support and represent the patients to ensure they receive the best and most appropriate health and social care. The clinical team also provide a link to other health care services and work closely with other healthcare colleagues. If Secondary Care is required then the patients are referred to the appropriate service or professional. Admissions to hospital will also be arranged if necessary. The



team also ensures that the patients' records are kept up to date with the recording of information received from outside agencies. The taking and sharing of information is done with respect to a patient's wishes taking into consideration the wellbeing of the patient.

Spring Hall Group Practice limited is involved in the training of GPs at different stages of their education. They are also a Primary Teaching Practice for Medical Students attending the University of Leeds.

Spring Hall Group Practice limited is also recognised as promoting student nurse training in General Practice and as such is a member of the Advanced Training Practice Scheme.

All practice staff undergo mandatory training and are encouraged to identify extra training to further their knowledge.
