1. Welcome and apologies	ACTIONS
Sally opened the meeting, welcoming everyone and round the table introductions were made. Sally welcomed Sam Pritchett and Philippa Bremner to the meeting	
2. Minutes of the previous meeting

3. Surgery updates – Liz Yeatman, Practice Manager, Belvoir Health Group Helena Pomeroy – Team Leader, Cotgrave Surgery Sam Pritchett – Team Leader, Cropwell Surgery

- Staff changes Sam Pritchett had taken over from Sarah Craig at Cropwell and was covering various other duties as well until replacements were found. Rachel Davison had returned from maternity leave as rota Co-ordinator - Due to the complexity of this role Liz is assisting at present as required. Matt Moore, based at Bingham is leaving at the end of March.
- Staff morale is difficult and tough when staff are off sick, everyone is assisting with covering the respective roles to keep things moving.
- There have been some negative remarks, from patients, on social media regarding the surgery and its staff, Please remember that the people in the surgery are doing a difficult job and trying their best to help everyone. Negative comments are not helpful and do remember that one day you might need their help. Let's not forget the positive comments and that a 'thank you' goes a long way and helps morale in a big way.
- Liz gave details of a trial Menopause Group Consultation which is to be held on 7 March at Bingham – 3.30pm – 5.30pm. This consultation is for ladies that are not already on HRT and have not previously seen anyone. It is NOT for follow-ups. If someone rings up wanting to discuss HRT the benefits of a Group Consultation should be put forward to start with as this might help because:-
 - Time with the GP will be up to 90 minutes rather than a ten minute appointment or multiple appointments that might be required
 - Lots of information will be given they will learn all they need to know, including being sent a video and information beforehand
 - A supportive group of women, during what can feel like a lonely time learn from each other's experience
 - Will get HRT prescription issued at the end of Group Consultation if needed. If this trial proves to be a success, there is the possibility of other Group Consultations being set up covering different subjects.
- A new telephone system is being installed in the surgery during the next few months
- The surgery thanked members of the PPG for their help with the filing/admin at the surgery this is always required. Any work carried out by the PPG is always confidential, all members having signed a Confidentiality Clause.
- Several complaints had been received about the signage, or lack of, leading to the Cropwell Surgery. It is not clear in the area it is situated and this should be looked at accordingly.

4. Well Pharmacy – Karen Alexander, Alex Castledine
Sally welcomed Karen and Alex from Well Pharmacy and an update was given:-What do we want from the Pharmacy?
 There have been a number of issues, the service improves then declines again. We need continuity. The Pharmacy is of prime importance and used a lot in Cotgrave and we need to be able to rely on the services it offers.
 There are now additional responsibilities with Pharmacies that have signed up for Pharmacy First, whereby patients can be seen by the Pharmacist and given the required medication or referred elsewhere if needed. This includes:- sinusitis
 sore throat impetigo shingles
 uncomplicated urinary tract infections insect bites ear infections
there is no charge for seeing the Pharmacist. If you pay for your prescriptions and one is issued that is all you pay for. When a Pharmacist sees a patient there are various questions asked leading to
various levels of triage and help will be given at every stage. Referrals will be made if required.
 There is frustration in obtaining certain medication. This, we know, is countrywide.
 Substitutions for medication not available is not an answer to a problem. Firstly, this is not legally allowed. Protocols and procedures have to be followed by the Pharmacy throughout and any changes have to be referred back to the GP to ensure that the contents of a substituted medication is correct and not going to cause any additional problems. It is not just a matter of being given an alternative. The Pharmacy does their best to obtain the required medication but due to shortages this is not always possible. Patients can always try another Pharmacy because of course they may still have supplies. Questions were asked about drugs/strengths of various medications that could be prescribed. Cotgrave now has full cover in the Pharmacy with two Pharmacists covering different days Monday to Saturday to ensure someone is always available. Advertising of the services offered under the Pharmacy First Scheme will be in Cotgrave Connections to clarify to patients what can be obtained and how. The Pharmacy use six different wholesalers for medication supplies. Legally they are required to use three.
• The timespan for obtaining a completed prescription legally is ten days. At present the Pharmacy is completing this within seven days.
 The Pharmacy is undergoing a refit at present and will have a fuller range of items available

11. Any other business – Update from David Adams re medication supply	
The following is a brief summary of the situation and problems with medication supply and dispensing:- (copies of this have already been circulated to the PPG)	
 2020 onwards - Major problems with patients unable to obtain prescribed medication started to occur post Brexit and during the Pandemic. 	

٠	Reasons: Patients were told that there were "manufacturing" problems especially	
	by staff at Well and other dispensaries.	
•	Consequence: Patients had to seek alternatives from the clinicians at BHG to	
	hunt for supplies widely. Considerable frustration and aggression resulted.	
•	During 2023 it became apparent that some these issues were not just	
	manufacturing but the result of price and policy decisions taken by DoH, NICE	
	and the new ICB locally.	
•	Conditions affected include but not limited to: Type 2 Diabetes, coronary	
	treatments, psychotic problems such as Autism, Hormone imbalance, certain	
	antibiotics for infections, dyspepsia remedies and epilepsy.	
•	January 2024: a poster appeared in Morrison's pharmacy in Gamston suggesting	
	that patients affected contact their MP. DA/SB wrote to Ruth Edwards.	
•	Details were requested and our concerns were discussed and raised with the	
	Minister for Health. He was aware of some of the issues. We suggested he and	
	RE contact local pharmaceutical professions or trade bodies to get lists of out of	
	stock or unavailable medications.	
•	We understand that this list is over 111 in January and an all- time high with an	
	annual increase of over 50% over 2023 reported in the media. Previous	
	shortages were sometimes transient, others were long term and the result of	
	NICE and ICB policy decisions we believe. The BHG team have been very	
	supportive of the PPG and patients during this time. However their teams have	
	frequently and regrettably been the subjects of aggressive behaviour.	
•	The latest position with certain drugs for Type 2 Diabetes is a global problem	
	and unlikely to be resolved this year according to Diabetes UK! These problems	
	are largely the result of licensing these products for weight loss programmes and	
	successful treatments, in addition to patients seeking private supplies at costs of	
	over £300 per month.	
	Next Steps - this subject has to be escalated to whatever level required in order	
	for results to be obtained.

•	A letter was e-mailed to our MP Ruth Edwards on 28 January outlining the	
	concerns of this subject. Detail of the response received on 12 February as

I can confirm that I have now passed this information to the Minister of State for Health and Secondary Care so that the Minister and his officials can investigate the shortages, having already met with him to bring local concerns about shortages to his attention. Please note that it may be several weeks until the Minister reports back to me.

In the meantime, I understand that there are global supply issues with glucagonlike peptide-1 receptor agonists (GLP-1 RAs), which are licensed for treating patients with type 2 diabetes, including the branded medicine Ozempic. This appears to be largely driven by off-label prescribing for weight loss, which has led to shortages of these medicines for patients with type 2 diabetes.

I am aware that the Government has issued guidance in the form of a Medicine Supply Notification (MSN), addressing all GLP-1 RAs, advising healthcare professionals on how to manage patients requiring these medicines. The Government is considering whether further communications are required.

The Government expects all providers of healthcare services, whether National Health Service or private, and all those with responsibility for prescribing to take appropriate account of national guidance such as MSNs. The guidance is clear that these medicines should only be prescribed for the treatment of type 2 diabetes, in order to protect supply for diabetes patients. Medicines which are solely licensed to treat type 2 diabetes should not be routinely prescribed for weight loss.

I know that the Government is working closely with national diabetes specialists, the NHS, wholesalers, all manufacturers of these medicines and the relevant regulatory bodies and agencies to address this problem and to understand how they can help ensure type 2 diabetic patients continue to get access to treatment.

I will be in touch once I hear back from the Minister and please do let me know if I can assist in the meantime." Ruth Edwards

- Is part of the problem based on licensing (MRHA) NICE and what the DoH will pay? Is this compounded by what our local Nottinghamshire Area Prescribing Committee says, thinks or does?
- This problem is ongoing and clearly affecting patients we just need to continue with this subject as it is a long and drawn out matter that will rumble on for a very long time.
- Patients need to communicate with Ruth Edwards so that she is aware and up to date about what is happening in the constituency. We cannot complain about a situation if we are not willing to do anything about it.
