- 1. Apologies Chrissie Ayre, Sam Troop, Celia Flinton, Maria Aylott.
- 2. Minutes of previous meeting held on 02.03 2022 Agreed.
- 3. Matters Arising from 02.03.2022 CH asked JM when it might be considered safe to resume health talks at the practice now that Covid restrictions have largely been removed in the UK. JM suggested the second half of 2022. CH unable to raise the impact of new housing on the practice at a recent CCG/PPG meeting, but agreed to speak to a District Councillor re Clinical Commissioning Group (CCG) and Newark and Sherwood DC planning department.
- 5. <u>Patients Feedback/Facebook Comments/DNA</u> JM gave us Did Not Attend figures for March 44 appointments were missed, eight clinical hours wasted.
- CP asked if it would be possible to compare March 2021 to March 2022. JM said there had been some improvement. CP reported that nothing had appeared recently on a local Facebook page re the practice. CP had attempted over several days to book an appointment by 'phoning the surgery after 8.00 a.m. He asked why there is still no online booking in place. JM said that online booking still on hold as every time the practice considers resuming that facility Covid figures start to rise again. JM said that the new online communication between patients and the practice now in operation. She also reported that patients with acute medical problems can now be given appointments at other practices within Sherwood Primary Care Network (PCN,) so far, most patients have turned down the opportunity, preferring to ring back next day to try to make an appointment at this surgery. The reception team has now increased to six staff and the hours operating has been increased. The practice is considering changing the telephone system, there are three years left on the existing contract, but a queuing system may be possible.
