### **Childhood Immunisations**

It's important that vaccines are given on time for the best protection. If your child missed a vaccine, contact us or speak to reception to book an appointment with our nurse.

#### Please contact the practice if:

- you think your child has missed any vaccinations
- or your child has a vaccination appointment but you've missed it or cannot attend

You can book or rearrange the next available appointment. It's best to have vaccines on time, but you can still catch up on most vaccines if you miss them.





## **Cervical Smears**

We would like to remind eligible patients that you are able to book your smear test with us. Please call the surgery to book your appointment with our practice nurse or have an appointment booked in our local Extended Access Hub in Eastcote.

Cervical screening is a way of preventing cancer. It tests for a virus called high risk human papilloma virus (HPV). High risk HPV can cause cervical cells to become abnormal. Most cases of cervical cancer are linked to high risk HPV.

## **Blood Test Requests from Hospitals**

We would like to inform our patients that we are unable to carry out any blood tests requested by hospitals.

These can be done at either Hillingdon Hospital or Mount Vernon Hospital.



The results of any hospital blood test requests should go back directly to the clinician/consultant requesting them in order for them to be actioned appropriately and in a timely manner.

# **Zero Tolerance Policy**

We treat our patients with courtesy and respect and ask for the same in return. We ask that you treat your GP and all other Practice Staff courteously without violence, abuse or harassment.

GPs and their staff have the right to care for others without fear of being attacked or abused. Any behaviour whether that be verbal, physical or in writing, which causes staff to feel uncomfortable, embarrassed or threatened, is totally unacceptable.

The Zero Tolerance policy includes abuse, aggression or threats made in person, over the telephone or in written communication, including on social media.

## **Sharps Boxes**

Please note that we do not accept any clinical waste in the form of injections / needles / lancets / syringes from patients without them being sealed in a sharps box. Recently these have been dropped to the practice in bags which is dangerous and can cause injury.



For patients who fall within the HA6 catchment area, both Three Rivers and Hillingdon Council provide a collection service for sharps bins and clinical waste. Patients can log onto the website and arrange a clinical waste / sharps box collection. Patients just need to have a sharps box prescribed.
