

HOW DO WE USE YOUR INFORMATION?

Your data is collected for the purpose of providing direct patient care. However, we can discuss this information, if required, by law. If you use consent, or if it is justified in the public interest.

The practice may be requested to support research, however, we will always gain your consent before sharing your information with medical research databases, unless we have to do so by law.

MAINTAINING CONFIDENTIALITY

We are committed to maintaining confidentiality and protecting the information we hold about you.

We adhere to the GDPR and the MHS code of confidentiality and security, as well as the guidance issued by the Information Commissioners Office (ICO)

RISKS STRATIFICATION

Risk Stratification is a mechanism used to identify and subsequently manage those patient deemed as being high risk or requiring urgent or medical care. Usually this includes patients with long-term conditions, such as cancer for example.

Your information is collected from a number of sources and the information is processed electronically and given a risk score which is relayed to your GP who then decides on any actions to ensure that you receive the most appropriate care.

INVOICE VALIDATION

Your information may be shared if you have received treatment, to determine which Clinical Commissioning Group (CCG) is responsible for paying for your treatment.

This information may include your name, address and treatment data.

All this information is held securely and is confidential, it will not be used for any other purpose or shared with third parties.

OPT-OUTS

You have a right to object to your information being shared. Should you wish to opt-out of the data collection please contact a member of staff who will be able to explain how you can opt-out and prevent the sharing of any of your information.

WHAT IS A PRIVACY NOTICE AND WHY DO WE NEED ONE?

WHAT IS GDPR?

The GDPR replaces the Data Protection Directive 95/46/EC and is designed to harmonise data Privacy laws across Europe. To protect and empower all EU citizen's data privacy and to reshape the way in which organisations across the region approach data privacy.

The GDPR comes into effect from Friday 25th May 2018

HOW DO WE COMMUNICATE OUR PRIVACY NOTICE?

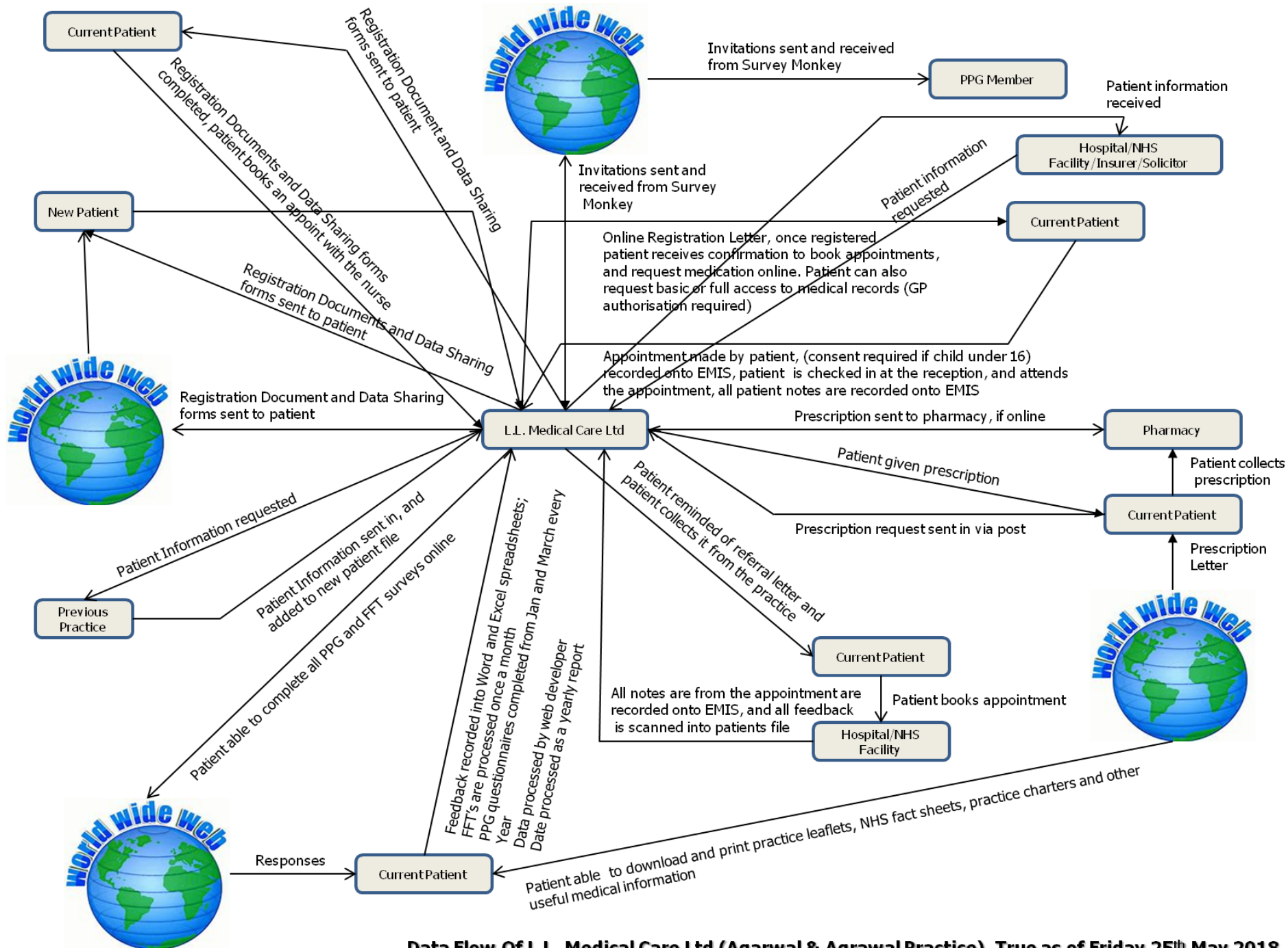
The L.L. Medical Care Ltd privacy notice is displayed on our website, through signage in the waiting room and in writing during patient registration (by means of this leaflet)
