# **Credit Control Policy**

#### Payment of all services.

All services received from the business must be paid for on the day of receipt.

All invoices for face to face appointments and telephone consultations are available same day for payment.

Face to face appointments can be paid by card, cash and cheques when departing the practice, after the service has been completed.

Telephone consultations (when available), for these a member of the reception team can collect payment in advance, if not the team will contact the patient after the completion of the service (if not able to reach the patient over the phone, a SMS / Email must be sent in regards the outstanding balance).

For payments that patients cannot make on the day with either face to face or over the phone these will incur a £5.00 admin fee for the receipt of credit from the business.

For other items ie prescriptions requested outside the appointments, these will be added to your account and will require to be paid when collection prescription from the surgery or if paid in advance the prescription will be sent directly to the pharmacy.

#### New patients to the practice

When joining the practice you will be required to make prepay, no credit services or options will be offered to you.

This will be reviewed at the six month period.

Face to Face in any of the three premises and pay directly with a staff member.

There is late payment admin fee of £5.00 added to any accounts not paid on the day.

Invoices are due for payment on the day of the invoice date. An overdue account fee will be considered and applied to all overdue accounts on a monthly basis until such time as payment is received in full. Credit for some services, including repeat prescriptions and JDOC, will be restricted until the overdue balance is cleared.

Account credit can and will be restricted for all overdue accounts. If credit is restricted, fees must be paid at time of requesting/booking any services.

Should the partners of the business decide that payments are not made, a payment plan can be offered and arranged. If continued miss payment should occur after this arrangement a debt collection agency will be considered to pursue the amount on the business's behalf.

## Non payment of services

The business reserves the right to disallow services and look to discharge a patient from the practice should the patient not look to resolve any financial issues it may be having in order to pay for services received.
