## **Privacy Notice – NHS Digital- Public WiFi**

Part of the NHS digital programme is working to make sure that everyone can access free WiFi in NHS sites in England. NHS WiFi will provide a secure, stable, and reliable WiFi capability, consistent across all NHS settings. It will allow patients and the public to download health apps, browse the internet and access health and care information. NHS Digital will receive monthly WiFi usage reports which will be provided by the CCG to show how much this access is being used. To enable reporting, a unique identifier (MAC) will be recorded from the device that accesses the WiFi. The MAC address is only used to record individual instances.
