

## Privacy Notice: PCN Data Sharing

Primary Care Networks (PCNs) are a key part of the NHS Long Term Plan, with all general practices being required to be in a network.

This practice is part of the Heritage Primary Care Network.

Heritage PCN is made up of a number GP Practices created to work collaboratively to ensure the health care system within our area works effectively by sharing knowledge and resources.

To enable us to work collaboratively in delivering care, we may share data about you with local partner practices who are also part of Heritage Primary Care Network (PCN) to provide the most flexible and accessible services for patients.

This will mean that GPs from other local practices will at times have access to your full GP record but only when providing direct care to you.

People who have access to your information will only normally have access to that which they need to fulfil their roles, for instance admin staff will normally only see your name, address, contact details, appointment history and registration details in order to book appointments, the practice nurses will normally have access to your immunisation, treatment, significant active and important past histories, your allergies and relevant recent contacts whilst the GP you see or speak to will normally have access to everything in your record.

Your data may also be shared with Heritage PCN for the following purposes:

- Online hub appointments.
- Face to face and telephone hub appointments.
- Condition identification and management

<p><b>6) Rights to object</b></p>	<p>You have the right under Article 21 of the GDPR to object to your personal information being processed. Please contact the Practice if you wish to object to the processing of your data.</p> <p>You should be aware that this is a right to raise an objection which is not the same as having an absolute right to have your wishes granted in every circumstance.</p> <p>For purposes of providing direct care, GP Practices process personal data under Article 6(1)(c) on a lawful and legitimate basis where the organisation is obliged under law to comply with</p> <ul style="list-style-type: none"> <li>• The General Data Protection Regulations (GDPR)</li> <li>• The Freedom of Information Act</li> <li>• The NHS Constitution</li> <li>• The Local Authority Social Services and National Health Service Complaints (England) Regulations 2009</li> </ul> <p>By complying with these laws, the Practice has compelling legitimate grounds for the processing which override the interests, rights and freedoms in the right to object.</p>
<p><b>7) Right to access and correct</b></p>	<p>Under GDPR and the Data Protection Act 2018, you have the right to see or be given a copy of any personal data we hold about you. To gain access to a copy of your information, you will need to make a Subject Access Request (SAR) to the Practice.</p> <p>You also have the right to have incorrect data held about you corrected.</p>
<p><b>8) Retention period</b></p>	<p>The data will be retained for the period as specified in the national NHS records retention schedule.</p>
