<b>6) Rights to object</b>	You have the right under Article 21 of the GDPR to object to your personal information being processed. You should be aware that this is a right to raise an objection which is not the same as having an absolute right to have your wishes granted in every circumstance.
<b>7) Right to access and correct</b>	You have the right to access any identifiable data that is being shared and have any inaccuracies corrected.
