

## Annual Report 2016 - 2017

This is the next annual report since the one written for 2013-2014.

# Introduction

This annual report covers the period from 1<sup>st</sup> April 2016 to 31<sup>st</sup> March 2017.

The past 12 months have seen many changes in Primary Care, along with many challenges. The GP 5 Year Forward View was published in April 2016, along with the report Making Time in General Practice published in Oct 2015 – both looking at how care will, and should be provided and delivered to our population in order to sustain Primary Care in the future. We have started to work on the 10 High Impact Actions in alignment with our own aims:

- Improving the Health of our Population best health and well-being outcomes for all our patients from the available resources.
- Enhancing the patient experience of care providing convenient and accessible high quality services
- Reducing per capita cost of health care maintaining practice profitability and contributing to a high value local health and care experience
- Improving the work life of our healthcare clinicians and staff employees and partners experiencing a feeling of meaning, success and fulfilment in their work.

This period was the first year of our budget reduction of £100k over four years, since our PMS review in 2015, and we have worked hard to maintain our services despite this challenging time. Our patient population has grown from 28191 to 28292. There are a number of housing developments in progress locally so we expect this to rise considerably over the next few years. There are approx. 1200 homes in our practice area with planning permission granted and building started, along with a number of large developments awaiting planning permission including Hampden Fields comprising 3000 homes and Woodlands comprising 1800 homes.

### **Partners**

Westongrove Partnership has 12 partners. Liz Ferguson joined on 1<sup>st</sup> April 2015 and Ameet Sahni joined in July 2016. Pippa Moreton retired in 2014.

## **Management Changes**

During 2016 the Partnership appointed Alex Bates to transition as Lead Partner in preparation for the retirement of Auds Walters in Jan 2018.

Following the departure of Louise Grant as General Manager in June 2014 after 12 years at Westongrove, we appointed a new General Manager Gary Edwards in November 2015 who left us in June 2016. This gave us the opportunity to review the management structure, and put in place a new senior management team that would take over the functions of the general manager.

To support the new SMT we appointed a number of new team members - Vicky Stump, Management Admin Support and Julie Matthews, Finance Assistant.

In August 2016 Annie Nelhams our Nurse Manager left the team, allowing us to introduce three Nurse Team Leaders – one at each site. Flick Haase, Beverly Campbell and Louise Ross were appointed. Louise Ross decided not to pursue this route, and Caroline Paddison was appointed in May 2017. We also utilised the consultancy services of Pam Robinson during this period to assist in developing the nursing team and the newly appointed Nurse Team Leaders.

#### 5 Year Strategic Plan

In January 2017 the SMT wrote version 1 of the Westongrove Five Year Plan linked to both our mission statement and the Five High Impact Actions.

#### **Training**

Westongrove continues to be a training practice with 6 approved trainers, plus the addition of 2 more from next year. In 2016 BGS took on FY2 training. We had a successful training visit from the Deanery when Ameet Sahni became an approved trainer to join the existing

team, and Dr Libby Symmonds was reapproved since joining Westongrove. We continue to take Fast Track Graduate students from Oxford Medical School.

We continue to be a learning organisation with regular clinical and PHCT meetings and monthly PTL sessions

## **Centralised Administration Team**

We are now in our second year of developing a centralised administration team to work across all three sites providing secretarial and administration support.

#### **Pharmacists**

During 2016 Westongrove collaborated with a number of local practices to SUCCESSFULLY bid for inclusion in the NHS England Pharmacist in Primary Care pilot. Our initial bid resulted in the appointment of Jen Weston a clinical pharmacist 2016, with a second subsequent successful application for a second junior pharmacist Jen Lowe joining us in September. During this time they have increased patient availability in areas such as medication review, hospital discharges, nursing home prescribing, MI training, Safety Alerts and providing valuable advice to the clinical team.

#### Weston Project and Community Teams

Our Weston Project has gone from strength to strength providing proactive care for our vulnerable over 75 patients, following our successful bid 2015 as part of an initial 12 month pilot, under the inspirational leadership of Dr Pippa Moreton.

- A manual audit of patients on the case load showed that in 2016, the total number of admissions prevented was 110.
- Patient feedback showed that 95% of patients felt their care at home was better since the Weston project had been working with them.
- Free text comments showed great appreciation for the patient centred approach and relationship of trust that ensure continuity and co-ordination.

- GP referrers felt that their patients had benefited from the service in 95% cases, saved the GPs time in 95% of cases and prevented hospital admission in 30% of cases definitely and 50% of cases probably.
- The Weston Project have also secured a number of step up beds at a local nursing home that have proved invaluable in re-enabling patients who may otherwise have been admitted into hospital or have had to stay in hospital longer.

We have recruited highly skilled team members, but it is continually challenging to recruit additional members due to the uncertainty of the funding every 12 months. We have continued to challenge the CCG about this.

The team were awarded the Bucks County Council Dignity and Respect Award in April 2016.

This model has also been rolled out to a number of other teas across our locality, with the support of Pippa.

During this period the Health visitor clinics were withdrawn from both BGS and ACS.

## <u>CQC</u>

Our initial CQC assessment in December 2014 resulted in a 'good' grade, but with some outstanding actions linked to legionella, PGDs, dispensary and emergency drugs trolleys. We had a revisit in January 2016 whereby the assessor was very satisfied with our developments and felt that the initial concerns were invalid.



## Research

During this period we sadly continued to see the decline of research studies but continued to be involved in Spire - cholesterol, AZ Declare and Abbot for diabetes, Novartis - COPD, RCGP – fluenz

#### Vasectomy Service

Westongrove continued to be the local CCG provider for vasectomies. Upon re-negotiation of the contract, the CCG withdrew the service as an NHS service and we ceased to provide in February 2016.

### **INR Services**

After a successful bid to provide INR services, we continue to provide this very valued service to the patients.

# **Technology**

Wifi installed at all three sites

Since 1<sup>st</sup> April 2016 Westongrove now offer patients enhanced access to their patient records including documents, consultations etc

Having commenced the use of Web GP as a 12 month pilot in January 2015, we reviewed it's use including patient feedback, and it was not seen to be cost effective so the contract was not renewed in Jan 2016.

We are keen to offer alternative ways for our patients to consult with us and access our services and are currently investing other solutions.

Westongrove has responsibility for anumber of nursing homes who have implemented the new Airdale system allowing nursing staff to access 24/7

#### QOF and CSP (Care Support Planning)

2016 - 2017 was our best QOF year ever, achieving maximum points in all areas except diabetes, where we missed DMOO3 – BP 140/80 or less by just 1% despite valiant efforts from the team. Mjog has been a very useful tool in gaining data from patients and assisted us in reaching the BP0002 target for the first time.

CSP continues to be developed and is successfully underway for diabetes. A patient feedback survey was undertaken after our first year developing the CSP approach and of the 15 responses received the feedback was very positive. Between 80% - 93% patients felt that:

- They had discussed what was important to them in managing their health
- They were involved as much as they wanted to be about decisions regarding care or treatment
- They always had enough information given to them
- They felt very supported by the clinician to help them manage their health
- Always felt that the care received was joined up and working for them
