# Why does my doctor charge fees?

GPs are not employed by the NHS, they are self-employed and they have to cover their costs in the same way as any small business. The government's contract with GPs covers medical services to NHS patients. The NHS covers the costs for NHS work only. In recent years, more and more organisations have been involving Doctors in a whole range of non-NHS work. This work is not funded by the government, so GPs have to charge a fee to cover their time and other expenses. Payment will be requested before we undertake the work.

# Why does it sometimes take my GP a long time to complete my form/ letter?

We have a standard 28 (working) day turnaround for these requests. There may be times when we are unfortunately not able to provide the information you have requested within this time frame, this is usually due to the pressure on the GPs workload as, understandably, clinical work and caring for our patient's health needs must take priority.

# Do GPs have to do non- NHS work for their patients?

Your GP may decline a request for a letter or completion of a report. To ensure your request is appropriate please refer to the following list:

We reserve the right to refuse private work for any reason We are also not usually able to facilitate requests for the doctor to write the letter in a specific way using specific wording. The doctor will write what is supported factually by your medical record.

We understand that patients are often wrongly advised to get a letter from their GP. More information about specific requests can be found below.

#### Fitness to...

Fit To: Fly, Dive, Skydive, Parachute Jump, Bungee Jump, Run a Marathon etc.

GMC guidance says all doctors must work within the limits of their competence, make clear the limits of their knowledge and make sure information in any document they sign is accurate.

As General Practitioners, we are not able to certify you as 'Fit To' participate in any of the above. This is outside of our area of expertise, for example we are not trained in Aviation medicine and so are unable to state whether you are fit to fly. A specially qualified clinician is most appropriately placed to do this and can perform any required investigations (such as an ECG, 24 hour blood pressure monitoring, etc.).

We would recommend that you find a suitable private service offering this assessment.

We can provide you with a summary of your medical record (detailing your past medical history and current medication) free-of-charge.

# Fitness to join a gym

The risk that harm would come to you by exercising is low, however we cannot say that it is 100% safe for anyone to exercise. The risk is entirely between you and your gym instructor, following the guidelines at the gym of your choice.

#### **Firearms Licences**

We are unable to assess patients for suitability in applying for a Firearms Certificate or renewal due to our conscientious objections to the holding of firearms. We follow British Medical Association (BMA) advice by supplying a free-of-charge letter stating that as a practice we have a conscientious objection to signing Firearms Licences. This can be given to

the police who can then organise your Firearms Licence. The police may advise that you obtain a copy of your medical records. If this is the case then you can request this via a Subject Access Request (SAR).

#### **Letters about missing court appearances**

Missing court is a serious matter. We will only provide a letter to the court if we are requested to do so by the court. Your solicitor will advise you further.

## **School Requests for Confirmation of Illness**

GPs do not provide sick notes for school children. Parents/guardians are responsible for excusing their children from school. When children are absent from school owing to illness, schools may request a letter from a parent or guardian, and this is no different during an exam period. Aside from the fact that parents/guardians are responsible for excusing their children

from school, GPs cannot provide retrospective sickness certification. When a child suffers from a long-term condition, any certification will be provided by the responsible specialist.

#### **Examinations**

The GPC (general practitioners committee) has sought and received confirmation from the Office of the Qualifications and Examinations Regulator that Awarding Organisations make no requirement for pupils to obtain a medical certificate in support of their application for special consideration.

Students are asked for information in support of their application, but this may take the form of a statement by the school. The Joint Council for Qualifications has confirmed that as far as they are concerned, if a student was absent from an examination as a result of illness and has the support of the school or centre to be absent, special consideration will be granted on that basis.

Awarding organisations do not insist that medical proof is provided.

#### Universities

If your university requests that you provide a letter from your doctor following absence through illness, then the university must request this in writing, accompanied by a signed and dated consent from the patient for the sharing of their medical information. The university will be invoiced for a medical report at the appropriate rate.

# **Letters of Support**

E.g. DWP appeals, Housing applications, Blue badges GPs receive frequent requests for letters of support. As we can only produce a factual letter from your records, it makes sense for you to do this yourself at no expense to you. All you need to do is to print the problem list and consultations within your medical history and then ensure you reference these in your application.

A chronological summary printout of conditions can be provided on completion of a Subject Access Request (SAR) if you are unsure of the date of your diagnosis. The practice will have up to 21 working days to complete this request. This is free for initial requests under GDPR legislation.

The assessors are looking at how your conditions are disabling you in your daily life. Therefore, it is the way you demonstrate your difficulties in your application that will help you.

#### **DWP**

GPs are not responsible for making decisions on people's benefit entitlement. The department of working pensions already has processes in place to request the appropriate information from GPs to enable DWP to make such decisions.

The DWP will contact your GP or healthcare professional directly to obtain medical evidence when you submit a PIP or ESA claim, the information is then sent to the DWP as part of your claim process. They will be responsible for paying any fee to the doctor providing the report. We are therefore unable to provide additional letters of support as the information we provide will be included in the report requested by the DWP.

#### **APPEAL of DWP Decision**

Having consulted DWP guidance to GPs, a letter of support will have no bearing on your application.

# **Blue Badge Applications**

You have to apply through your local council - your GP can't help you get a Blue Badge. Your local council might also arrange an appointment to visit you - they'll let you know if you need this.

# **NHS APP- Access to your online records**

# Patient access to their medical records (SAR - Subject Access Request)

The Uk General Data Protection Regulation (UK GDPR), which was implemented in the UK through the Data Protection Act 2018, gives individuals the right of access to their personal data from any health and care organisation that holds records on them.

This right is commonly referred to as "Subject access"

A data subject access request form will need to be completed; signed & ID seen before we are able to complete these requests.

In most cases you will not be charged a fee for a SAR. However, we can charge a 'reasonable fee' for the administrative costs of complying with a request if it is manifestly unfounded or excessive, or if an individual requests further copies of their data.
