7.	NHS/DC/ICB Initiatives	No issues were suggested for taking up. There were a wide range of initiatives that come on the NHS list of topic areas that could be taken up by NMC. 8.	Flu, Covid and RSV vaccines/boosters	The Covid booster programme has nearly been completed.
9.	PPG Initiatives	The matter of enquiries at reception at around 11.00 am blocking patients trying to make a booking at the reception for an afternoon appointment was suggested. Did the surgery still issue numbered ticket for those turning up to try to book an appointment? It was noted that the numbered tickets were no longer used. There is a QR code for making feedback/queries for consideration by the PPG. A paper version of the feedback form will be made available on request.

10.	Surgery Issues and Staffing News	There is a new pharmacist, Meera Uppal, who has joined the practice team. Also a new pharmacy technician will be joining the practice on 1 st July 2025, to enhance our in-house pharmacy team.
11.	A.O.B. and this meetings question.	Appointment access – increased use of triaging. The matter of abuse of reception staff, acting in both a face-to-face and telephone mode, was noted. This was obviously not acceptable and could make staff stressed. It was noted that patients could be stressed. The various ways of dealing with these issues was noted.

	The on-line question and answer system was noted.
	The following issues were raised via the QR code:- a) 'When it is 11 am put up a sign saying only people who want to book appointment go to the desk at that time. Otherwise people ask other questions then and the people on the phone get appointments instead as you get stuck behind them.' b) 'Implement online appointment booking e.g. via AskMyGp, Systemonline or NHS App. AskMyGp is used at South Wigston Health Centre, and it is super convenient. While there is a contact form via the NHS app, the answers are normally to book appointments over the phone or they send you a link to book. Having a direct option to book an appointment would so much time.'
	NMC is reviewing booking of appointment options and procedures for patient access.
