1. Welcome and Apologies

- Meeting opened with introductions from all attendees.
- Long-standing and new members present; demographic of attendance noted.
- Apologies received from members unable to attend (names not provided in transcript).

2. Minutes of Last Meeting & Action Log

- Minutes were circulated promptly after the previous meeting.
- Page numbers requested by Ralph have been added.
- **Citizens Advice service**: likely discontinued due to funding; practice to confirm and update PPG if an alternative location is found.
- PCN changes: Novum has moved from Sevenfields to the newly formed Ravensbourne PCN.
- **Social prescribers**: Service unchanged; still active though locations may vary. Referral numbers to be checked by practice.
- Document handling & communication: No delays reported by admin team; further clarification needed regarding specific patient concerns.

- Normal results automatically visible on NHS App.
- o Slightly abnormal results generate routine follow-up within two weeks.
- Clinically urgent results should be actioned by GPs on the day they arrive, not held for the requesting GP's next session.
- Issues acknowledged with external hospital systems lacking integration with GP records.
- Laboratory and sample issues: Concerns raised about Synnovis quality, delayed processing, and incorrect requests for clinician PINs; practice to audit and escalate externally as needed.
- Al transcription (Accurx Scribe): Concerns noted about inaccuracy at hospital clinics; importance of patient consent and accuracy checking stressed.

3. Chair's Report

- Visit to *Healthwatch Lewisham* interest in supporting PPGs and patient experience groups; could be invited to a future meeting.
- Work underway to gather views from children and young people on health and wellbeing.
- Cancer screening update: leaflet available; discussion on low uptake and ways PPG can help promote awareness.
- Parish nurse scheme developing in local community groups.

4. Practice Report

- Two new GPs joined in September:
- Physician Associates (PAs): 6 in total, rotating across sites, reporting into Dr Morris.
 They cannot prescribe but undertake extended assessments and clinical tasks under supervision.
- Staffing turnover minimal; recent GP departures due to relocation.
- PCN resources increased: four pharmacists now supporting medication safety and audits.
- Flu and COVID vaccination:
 - o Booked appointments more successful than walk-ins.
 - o Saturday clinics ran at both sites when possible.
- Accurx Scribe AI note-taking trial ongoing; clinicians report strong accuracy and efficiency. Dr Morris to demonstrate at next meeting.
