Privacy Notice - Telephone Calls

We may record telephone calls for training and monitoring purposes and for the protection of staff, doctors and patients. Access to these call recordings are limited to the Partners, Practice Manager, Deputy Practice Manager and the Reception Manager only. Call recordings are permanently deleted after a period of 12 months.

Call recordings are rarely accessed and only when there is a legitimate reason to do so. Uses can be to see evidence of abuse by patients, to clarify what was said in conversations when a dispute is experienced or to recall information in order for the practice to carry out its public duties. Call recording may also be used to investigate a complaint.

These recordings will not usually be shared outside the practice. If we hold recordings that have not been deleted you can ask for copies by writing to the Practice Manager.

If you object to your call being recorded we can delete it immediately after the call. We are required by Articles in the General Data Protection Regulations to provide you with the information in the following 9 subsections.

6) Rights to object	You have the right to object to some or all the information being processed under Article 21. Please contact the Data Controller or

	the practice. You should be aware that this is a right to raise an objection that is not the same as having an absolute right to have your wishes granted in every circumstance.
7) Right to access and correct	You have the right to access the data that is being shared and have any inaccuracies corrected. There is no right to have accurate medical records deleted except when ordered by a court of Law.
8) Retention period	We will keep call recordings for a period of 12 months.
