Another Challenging Year

2025 has been another challenging year for the Grove Medical Centre primarily because of increased demand, limited resources, service redesign, facility constraints, and the knock-on effects on staff and patients. The practice has been proactively managing these issues (e.g., through triage, online systems, internal re-modelling) but the pressures remain significant.

The Practice patient list continues to grow with 13,085 registered patients (October 2025).

The annual NHS GP Survey continues to highly rate the overall patient satisfaction with the Practice.

More recently there has been an increase in abusive behaviour towards Practice staff.

Your Patient Participation Group has worked closely with the local authority by attending and reporting to every meeting of Sherborne Town Council, thereby keeping health and care prominent on the agenda.

Furthermore, your Patient Participation Group is represented on the Sherborne Area Multi-Agency group associated with the health and wellbeing of young people.

In addition, your Patient Participation Group continues to work closely with both the Social Prescribing Team and the local Health Champions.

Three students from Sherborne Girls School represent young people on the Patient Participation Group.

This year your Patient Participation Group has produced four editions of the Grove Newsletter.

The newsletters have carried a variety of health-related subjects. Not only did they contain articles relating to the Practice itself, but there were several articles relating to information on, and coping with, a variety of health conditions.

Although our regular contributor to articles entitled 'A View from the Waiting Room' had retired, we have still managed to produce articles for each of the editions, however we would welcome contributions from our patients.

As a patient group we are grateful for the trust that the Practice places in us the produce the regular newsletters on their behalf. Of course, articles containing information of a medical nature are not published without the authority of the Practice.

- Supported MyTime Young Carers
- Produced health related information for young people moving on to university or full-time employment
