Questions for May meeting

Some of the social prescribers in the city are being made redundant from the summer. What is the situation with our social prescribers at Drayton?

As they are a massive asset to the surgery is there a plan if their jobs are at risk?

I wasn't aware of this but would assume that the Social Prescribers who are being made redundant are part of a third-party company. Portsmouth North PCN took the decision from the outset to recruit ourselves and our Social Prescribers will be going nowhere.

Has there been any evidence of reduced waiting lists since the "out-of-hospital setting" initiative was started and has it caused additional work within the surgery.

Because we only ever send off referrals, we don't see reductions or increases in waiting lists. If patients contact us about the wait on their referral, they are directed to ring the department secretaries as we are unable to influence or adapt. We certainly haven't noticed any additional work at our end.

Drayton surgery is increasingly using Practice Plus as an option in accelerating certain treatments.

Of the eligible patients what has been the percentage take up for the 2025 Spring booster

We have vaccinated 55.6% of the eligible patients, with 44.4% remaining. This breaks down to 1,566 patients having had the vaccination and 1,252 remaining
