1. Aims and Objectives

We aim to give primary care a voice at a citywide level, run citywide primary care and community contracts, support practices in difficulty and shape the development of new services in the city. We also want to develop ways to help practices with the day to day challenges of running a practice.

In achieving this purpose, Leeds GP Confederation will aim to help practices remain sustainable by building on the attributes of primary care. These attributes being;

- It is well recognised and highly valued service where people already access a lot of their care;
- A model of care that is based on building long term relationships with people, families and communities, an approach which aligns with local care partnerships;
- It provides cradle to grave care, the majority of care pathways involve general practice;
- It has advanced IT systems and some of the most complete clinical records for the people it serves;
- Works in a registered list based way, which allows for the development of proactive models of care delivery seeking to improve outcomes for people and populations over years;
- Enable practices to play a full and active role in quality improvement, service integration and pathway development, aligned with the local care partnership vision;
- Create a governance system that enables practices be active in contributing to both local and citywide strategy;
- Create an organisational structure which is able to hold contracts and deliver services;
- Drawing on the different strengths of our practices, localities and federations, we aim to strengthen primary care and improve patient care;
- Listen & Act.

4. Leeds General Practice Confederation Limited

White Rose Park is the headquarters and head office for the Leeds General Practice Confederation. It hosts the executive team, the clinical leadership team and the operations management team and provides a base from which services are managed and supervised.

The clinical provision of services takes place in consulting rooms within GP Practices and health centres in the community of the Leeds population. The clinical services provided by the Leeds GP Confederation are not the primary services being provided from the health centres and GP practices that host them (therefore under rule 8(b) of the CQC guidance 'What is a location?' these are not locations in their own right and the main location from where the services are managed is our registered location). This is true of all clinical services, including Enhanced Access, Same Day Services including acute respiratory, Leeds Community Dermatology Collaborative, Leeds Sexual Health Services and ADHD symptom support and signposting service (delivered in partnership with Leeds & York Partnership Foundation Trust).

The head office is comprised of purpose built offices which are occupied by NHS Leeds Community Healthcare Trust and let to Leeds GP Confederation under a usage agreement in order to manage the running of Leeds GP Confederation and its services. The offices comply with all of the necessary regulations and legal standards required for the purpose for which they are used.

The individual locations from which clinical services are provided are hosted within the buildings of GMS/PMS/APMS contract holding GP Practices, or other NHS contracted community or primary care services located in geographically appropriate locations to assist the population attend services that meet their local needs. The facilities as such are managed by the occupying services to the standards of the provision of NHS GP services in that the environment, access, equipment and health and safety arrangements in each of these buildings are appropriate to the provision of primary care consultations and care.

Each site where care is provided is staffed by suitably qualified and trained staff who have met the minimum standards of training and competency as well as a site specific induction to enable them to carry out their roles (both clinical and administrative) in a safe and effective manner.
