	Patient Survey Discussion on the patient survey, Vivien shared how the data is presented. Data can be filtered by sites and other categories.	Vivien to pull EMIS search for patient language data and feedback at next meeting
3	Turkish PPG Update Vaccination centre held two Turkish speaking vaccination clinics on the 24 ^{th of} January and 31 st January 2024. MHP had translated posters, and the Turkish PPG group invited the community. We will look at holding these clinics again in the new season. Maggie from Turkish PPG Group advised that there are several vaccination clinics we can provide for the community. We Look	Vivian to provide future
	forward to working together on more. Maggie is open to come to MHP sites during clinics to help with dedicated translation clinics. 7589 of our patients are Turkish speaking and 4419 are coded as needing a translator. Vivien will run an EMIS search for patient language data and report back in next meeting. Will be useful in determining which translations are most needed.	Vivien to provide future translated clinic posters to all PPG members.
	Punam Knowles requested some posters where she can promote the clinics. Vivien will make the translated posters available to all members.	Vivien to send Maggie the MHP Outreach information.
	Nigel advised that Patchs has a Turkish translation service that has currently not been enabled at MHP. MHP website does not have domestic abuse and mental health support information. Turkish PPG may be able to support some translation with information on these.	Vivien and PPG members to work on signposting information for website.
4	Food Bank Project Very well received, the next time we take part which will be in April 2025, they will provide us with a certificate.

	Patchs Telephone Assistant Alma Healthcare Centre has now joined the Patches telephone triage model. Vivien shared information about which sites are currently enabled for Patchs Telephone assistant.	
	These are: Alma, Carlton House & Connaught, Lincoln Road and Freezywater. Vivien explained the Telephone Patchs Assistant process.	Vivien and Punam to discuss Patchs tele assistant issues offline.
	Punam advised that she has tried to use the Patchs system but is being cut off without support. Vivien will speak to Punam directly and investigate the issues.	Vivien to check sites Patchs set up as currently some are non-compliant. Check with Practice Managers.
5	Digital team are looking at short survey to text patients that have used Patchs telephone assistant. Once set up, on the same day patient submits Patchs via telephone, they may receive a text to ask about their experience and ease of use.	
	Leena cannot get into Patchs account, when phoning for an appointment and there are no appointments available and keep getting looped back to the automated system by receptionists. Vivien will feedback to LRMP.	Vivien to feedback to LRMP about transferring patients to Patchs without checking capacity.
	Babble Upgrade – Call back Feature Call back feature now activated. Vivien asked the PPG members if they have used the feature yet. No members have used yet. Vivien explained the model and so far we have had positive feedback.	
	Maggie from Turkish PPG group gave good feedback on the call back feature from the Turkish community patients.
