Ruth opened the meeting, thanked everyone for attending and introduced the pharmacy team members. Liz, Brooke, Ramandeep Bains and Sally Hale explained the services they provide, based from the GP surgery. Liz started on her own in 2019 and there is now a team consisting of 7 pharmacists, a trainee technician and 3 technicians. Ramandeep spoke about different clinics they run, hypertension, lifestyle changes, discharges, medication side effects and safety alerts. Sally explained how she deals with blood pressures, ICB targets and savings, care home support, care home support – helping care homes to order online. Paul Witts enquired whether more prescription requests come via the surgery or online. Liz responded saying more requests are moving online, less so from community pharmacy. KK added that we have good pharmacy/GP relationships. We have a direct dial and dedicated e mail address for pharmacies.
