## **Privacy Notice – The Driving and Licencing Authority (DVLA)**

The Driving and Licencing Authority (DVLA) are required to assess whether licence holders are fit to drive if a patient is recently diagnosed or has a condition which may affect their fitness.

The patient must inform the DVLA if this is the case however in certain circumstances, a GP may contact the DVLA with a Patient's consent or, if a GP believes their patient will not report their condition, contact the DVLA without consent to protect the public.
